is a compact board coated with melamine resin on both sides.

Core: Melamine resin impregnated glass fibre (white)

Coating: 0.2 mm (190.4 g/m²) melamine resin impregnated base paper (black) on both sides

Density: 1900 kg/m³ Thickness: 3 mm – 15 mm

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on any metallic base or non combustible base.

Approved for all colour variations. Maximum organic content: 20 wt%

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
